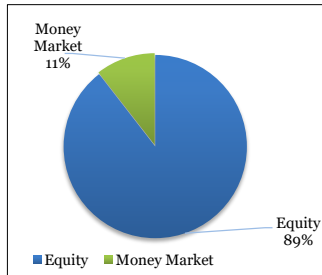
### Investment Manager Profile

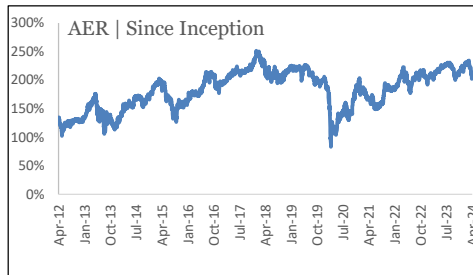
