

## PLS reopening for NJ Platinum Portfolio new business auto coverage on March 13!

Effective Monday, March 13, we will reopen our PLS System for Platinum Portfolio New Jersey automobile coverage for new business customers. The catalyst for this change is to provide you with more options for your new business customers, and the PLS System offers many ease-of-use benefits that are not available in the NJ Non-Masterpiece Auto System.

### Benefits of using the PLS System for NJ auto

Beyond the automated self-service advantages of the PLS System, this solution also affords the following benefits:

- The ability for agents to view and print policy documents, inspections, ID Cards, and billing info directly
- A Deductible Reserve benefit for comprehensive and collision deductibles of \$1,000 or more (10% of the deductible is added to the reserve for each loss-free year)
- The ability to write more than four vehicles on one policy
- Broad coverage options, such as full window glass, loss of use, road service, loan/lease GAP, and more. (See our [NJ auto comparison](#) for more information)



### Other important things you should know

- Atlantic Employers Insurance Company (AEIC) is the primary writing company for NJ auto through PLS. Banker's Standard Insurance Company should only be used when:
  - Packaging a NJ auto policy with an existing Platinum Portfolio homeowner policy that also includes out-of-state coverages, or;
  - A non-NJ domiciled agent is not licensed to write in AEIC
- Platinum Portfolio auto policies can qualify for package rating and Multi-Car Discount when accompanied with a qualifying Platinum Portfolio or Masterpiece policy.

### Submitting NJ Auto Platinum Portfolio new business requests

Effective March 13, you can start quoting your NJ auto policies directly in the PLS System. It's the fastest and most efficient way to generate a quote.
