## Information needed to get a ForeFront quote

- Operations/Industry/SIC Code
  - Details in the consolidated financials
  - Employee count
  - USA and California employee count
  - Pension plan asset value
  - Revenue from sales to the USA
  - Number of employed lawyers
- Confirmation that the Applicant has:
- Been in business for over 3 years
  - Not filed for bankruptcy in the past 5 years
  - Not had any insurance cancelled or non-renewed in the past 3 years
  - Not closed locations, chapters or subsidiaries in past 12 months or is expected to in the next 12 months
  - No losses in the previous 5 years



## Non-qualifying business types
