


#### **Asset Allocation**

#### **Market Commentary**

In June, Indonesia reported deflation of -0.16% on month or inflation of 1.33% on year, a decrease from 1.68% in May. COVID-19 cases in Indonesia increased as a result of the Eid holiday. The government implemented a mobility restriction (PPKM) in Java - Bali from July 3, 2021 to July 20, 2021. At the end of June, the Jakarta Islamic Index (JII) closed lower by -4.11% in the month. It was recorded that there was an inflow of foreign investors during the month of June to the stock market amounting to IDR 4.9 trillion. The yield on the 10-year government bond rose from 6.439% to 6.560% in June. At the end of June, the Infovesta Sharia Bond Index closed slightly higher by 0.28% on the month. During the month of June, there was an inflow of foreign investors to the bond market amounting to USD 1.3 million.
