

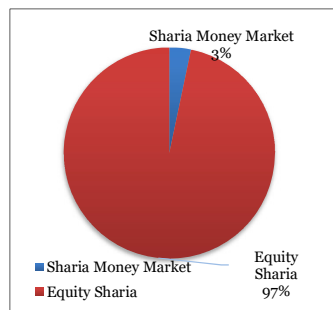
### Investment Manager Profile

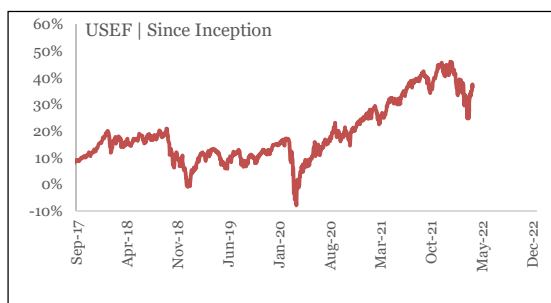
