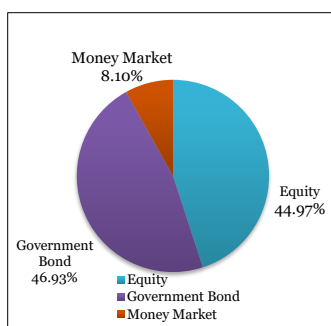
Investment Manager Profile

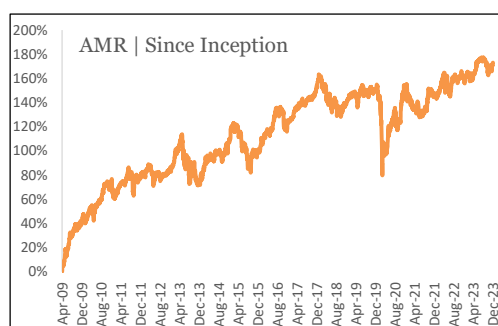
