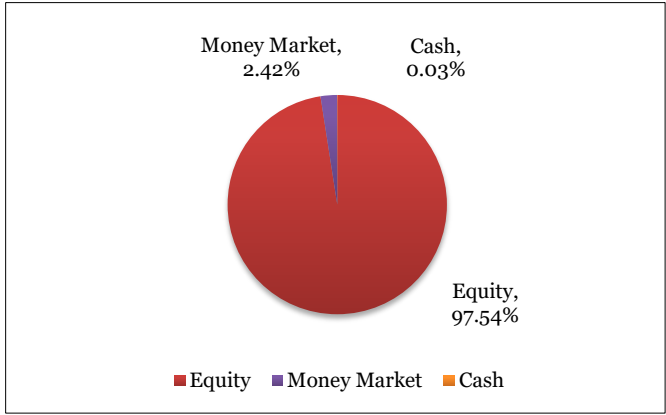
Investment Manager Profile

Asset Allocation



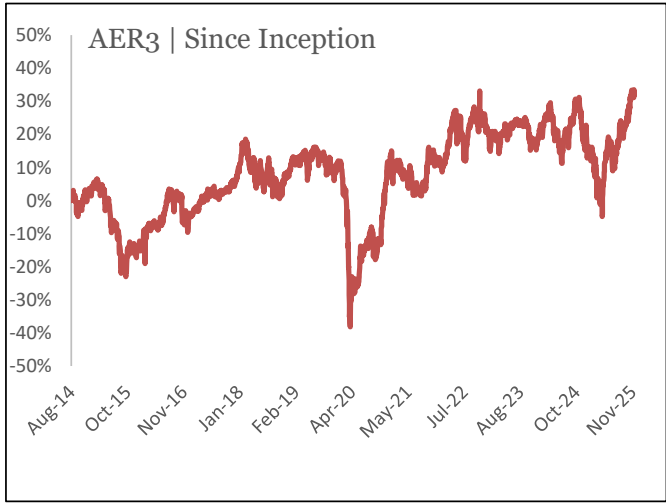
