

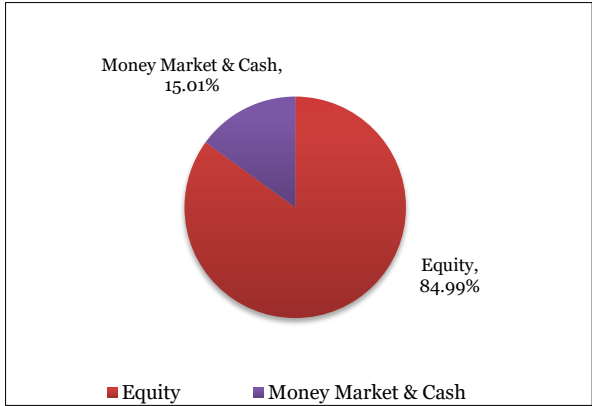

Asset Allocation



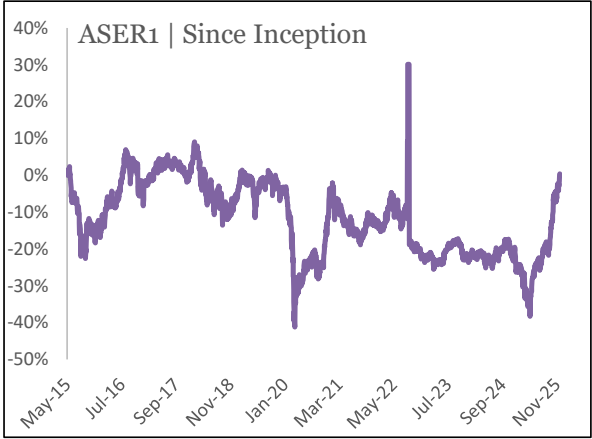
