Asset Allocation



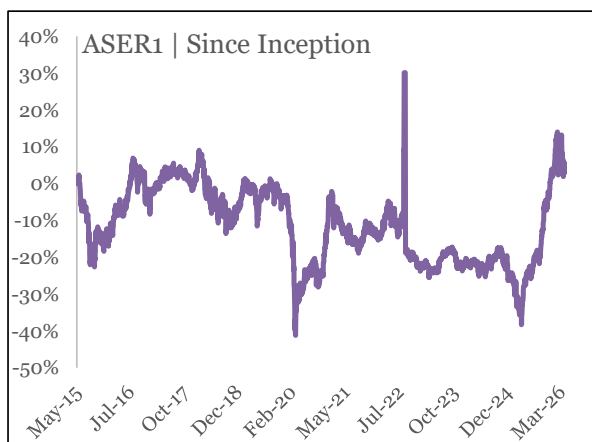
