Impairment Form

Completing this Form

All impairments to fire protection equipment should be recorded and strictly controlled by site management. This form should be used to notify Chubb Insurance Singapore Limited when fire protection systems (sprinkler systems, fire detection systems, gaseous agent fire suppression systems, etc.) are impaired in accordance with the following criteria:

- Impairment/isolation exceeds 8 hours duration or extends overnight and
- Impairment/isolation affecting more than 10% of the complex/building.

The completed form should be emailed to Chubb at **fireimpairment.sg@chubb.com**.

The relevant section of the form should be completed and further notification provided once adequate protection is restored.

Important Note: The Extent of The Impairment Should be Limited to Specific Areas or Alarm Zones.
