Terms and Conditions



These Terms & Conditions form the Agreement between you and Chubb Insurance Singapore Limited (“Chubb”) arising from your participation in the Insurance Promotion wherein you have expressed interest to obtain the complimentary \$1,500 home contents coverage (sub-limit of \$750 for personal household electronics appliances) with HomeInsured™.

The Terms and Conditions henceforth are set out for HomeInsured and may be added or changed without prior notice.

1. HomeInsured is a twelve (12) months complimentary home contents plan providing coverage for your home contents, renovation and, fixtures and fittings in the event of fire. In the event of fire resulting in the damages to or loss of household contents, renovation and, fixtures and fittings, Chubb will pay you up to S\$1,500 (with a sub-limit of \$750 for personal household electronics appliances) subject to the terms and conditions of the policy.
2. Pursuant to Section 25(5) of the Insurance Act Chapter 142, you are to disclose in your application for the Insurance Promotion fully and faithfully, your Personal Data to Chubb, otherwise the policy issued hereunder may be void and you may receive nothing from it. Chubb has only provided you with product information. You should seek advice from a qualified advisor if in doubt.

To be eligible for HomeInsured, you need to be:

- a. At least 18 years old; and
- b. Not insured under any complimentary home contents plan underwritten by Chubb in the last 12 months preceding the date of your participation in the Insurance Promotion.
3. Chubb reserves the right to reject your HomeInsured application in accordance to its internal policy without any notification.
4. Upon the successful application of HomeInsured, you as a Policyholder will be covered immediately from the day you have participated in the Insurance Promotion (“Commencement Date”). You will receive your fulfilment pack, containing your policy documents (including policy schedule) within 7 working days by electronic mail sent to the electronic mail address indicated in your application for HomeInsured. If electronic mail address is not available, you will receive your fulfilment pack within 7 working days by postal mail sent to the service address indicated in your application for HomeInsured.
5. HomeInsured will be cancelled automatically on the date falling 12 months after the Commencement Date. Chubb may cancel the policy by giving 1 month’s prior notice. The company strives to maintain your coverage at existing terms. We may effect changes to your policy with 30 days advance notice. Excess may be applicable for each claim.

7. This policy is protected under the Policy Owners' Protection Scheme which is administered by the Singapore Deposit Insurance Corporation (SDIC). Coverage for your policy is automatic and no further action is required from you. You are deemed to have given consent and authorisation to Chubb to collect, use, disclose, and/or process your personal data or information supplied to Chubb without further notification to you, confidentially with its affiliated companies, third party service providers, business partners and/or other parties which may be sited outside of Singapore, for administering policies taken out with Chubb, customer services and to allow Chubb and/or its business partners to perform marketing and related activities, until Chubb receives your written instruction to the contrary. Upon your written request, Chubb shall, without charge, cease to use your personal information for purposes other than those directly related to this Policy.
