Dear Policyholders and creditors of Chubb Samaggi Insurance Public Company Limited,

We, Chubb Samaggi Insurance Public Company Limited (the “**Company**”), wish to inform you that the Company will amalgamate with Cigna Insurance Public Company Limited (“**Cigna Thailand**”) with effect from 1 March 2023 (the “**Effective Date**”), in accordance with the Integration Plan between the Company and Cigna Thailand as approved by the Insurance Commission.

In this regard, Extraordinary General Meeting No. 1/2022 of the Company and Extraordinary General Meeting No. 2/2022 of Cigna Thailand, held on 11 November 2022, have passed a resolution to approve the amalgamation of both companies. In addition, the Company and Cigna Thailand have already obtained approval for the amalgamation from the Office of Insurance Commission according to Section 13 of the Non-Life Insurance Act, B.E. 2535 (1992) (as amended).

Upon the Effective Date, the Company and Cigna Thailand will cease to exist, creating a new company (the “**NewCo**”), named “Chubb Samaggi Insurance Public Company Limited”, which is the current name of the Company. The Company's business including all of its existing insurance policies will be transferred to the NewCo by operation of law.

As of the Effective Date, as for the policyholders, your policy will continue to be insured by the NewCo, which will operate under the current Company's name, “Chubb Samaggi Insurance Public Company Limited”, with full force and effect in accordance with the terms and conditions of the existing policy in all respects throughout the policy period. Any claim and renewal in respect of the policy shall be made to the NewCo as if it were the original insurer. As for the creditors, the NewCo will become the party of the contract in place of the Company and assume all rights and obligations that the Company has with full force and effect in accordance with the terms and conditions of the existing contract as if the NewCo were the original contract party. Your rights and obligations under our contract with you will remain unchanged, and you will continue to be our valued business partner.

As part of the amalgamation, we transfer your personal data to Cigna Thailand and the NewCo pursuant to the details set out in the Chubb Master Privacy Policy at <https://www.chubb.com/th-en/footer/privacy-policy.html>. Upon the Effective Date, the NewCo, as a data controller as defined under the Personal Data Protection Act B.E. 2562 (2019), will be responsible for the handling of your personal data pursuant to the details set out in the NewCo Privacy Policy <https://www.chubb.com/th-en/footer/new-privacy-policy.html>.
