What do I do if I have a claim?

Your first step is to refer to your policy wording so that you can comply with its claim notification requirements. These can be found under Condition 5.4. You will then need to provide written notice of your claim to our claims department at the following address:

Your claim will be allocated to a dedicated adjuster who will review your claim notification and provide an initial response.

What do I do if I need to instruct a law firm?

If you are seeking written consent to instruct a law firm to represent you, our claims adjusters will consider your written request.

It is a decision that can be all the more challenging if you are not familiar with the legal services market.

Recognising some sections of the policy call for particular specialism in D&O Criminal Claims (“white collar” crime claims) and related/complex regulatory investigations, names of pre-eminent firms with this niche expertise are also provided.

Chubb will provide payment for your legal costs in accordance with your policy’s terms and conditions. Our claims adjusters will regularly and pro-actively liaise with you and with your chosen law firm throughout the life of your claim.

The solicitor/client relationship will be between you and your choice of law firm. Security and confidentiality of data that you may choose to share with your law firm for example, would be a discussion and agreement between you and them. Our due diligence is limited to the firm’s competence, capability and rates, which has already been undertaken on the firms listed below.
