Faulty Packaging Compromises Clinical Trial

Description of event

A contract manufacturing organization (CMO) was contracted to make a drug to be used in a clinical trial. The CMO's customer claimed that an error on the part of the CMO compromised its product, and its failure to meet contract specifications regarding product quality led to a delay in the clinical trial and subsequent financial loss. Investigation revealed that the CMO's packaging design possibly contributed to degradation of the trial product.

Resolution

The claim was valued at circa €1,700,000



Insufficient Radioactivity Produces Unsatisfactory Results

Description of event

A contract manufacturing organization supplied to its customer radioactive sulfate that was less radioactive that indicated on the label. This produced unsatisfactory results in the client's experiment, forcing the client to repeat their work.

Resolution

The claim was resolved for €400,000



Alleged Copyright Infringement

Description of event

A medical device company's advertisements were alleged to infringe on another company's registered trademark and slogan. Most of the cost of the claim was for extensive discovery and litigation expenses.

Resolution

The claim was valued at €1,225,000

Manufacturing Error Causes Bodily Injury

Description of event

Frequent long-term use of a generic product was linked to a disorder that causes uncontrollable repetitive body movements. The manufacturer was sued by a consumer with alleged injuries from side effects, who claimed that the manufacturer failed to warn of those side effects. The case resulted in significant defense expenses and a negotiated settlement for the alleged injuries. Subsequently, a "black box" label was issued that explicitly warned of this potential side effect.

Resolution

Damages exceeded €2,500,000



Product Misuse Turns Fatal

Description of event

A teenage boy was prescribed an oral antibiotic to treat acne, even though this was an "off-label" use for which the product was not approved. He developed rash, fever and inflammation of internal organs. He was in intensive care for four months before dying from the adverse reaction. His medical expenses were more than €2.5 million.

Resolution

Damages exceeded **€4,000,000**

Description of event

A contract manufacturing organization (CMO) manufactured orthopedic implants to a customer's specifications. After the product began causing bodily injury, the parties looked to their contract to define each party's responsibilities. While the contract included mutual indemnification language, allegations from claimants cross over to both parties' contractual obligations, thereby making it difficult for the CMO to extract themselves from the litigation.

Resolution

Claim estimated at €4,000,000



Contaminated Syringes Cause Patient Illness

Description of event

Patients filed suit against a medical device company alleging that the company's pre-filled syringes were contaminated with bacteria, causing the patients to become violently ill. The syringes were manufactured by a third party contract manufacturer.

Resolution

The claim resolved for more than €1,000,000

Water Damage Floods Facility

Description of event

An incubator in the claimant's second-floor lab caught fire, triggering the sprinkler system. The fire was contained and the building was evacuated. Sprinklers continued to run for 45 minutes because the fire department refused to enter the bio-hazard facility, being unfamiliar with the potential hazards to firefighters. Water pooled on the floor and leaked down to the first floor, damaging equipment, personal property and research and development property, and triggering significant extra expense to move production to another facility.

Resolution

The claim was valued at €750,000



Power Outage Contaminates Drugs

Description of event

A power outage from vehicle damage to a nearby utility pole disrupted a manufacturer's in-process batch of biologic drugs. The disruption resulted in some contamination, diminished production in the affected bioreactors and a loss of revenue from the inability to meet market demand for the drug.

Resolution

The claim was valued at €750,000



Power Surge Destroys Samples

Description of event

The refrigeration system in a pharmaceutical company's research department failed due to a power surge. The back-up power unit was not self-starting, and personnel did not re-start the unit in time to maintain the controlled environment. Specimen samples that took weeks to develop were destroyed.

Resolution

Damages sought exceeded **€450,000**

Broken Capsule Lead to Lost

Description of event

After a small fire in a medical device production facility, it took three weeks to repair the damage, but more than four months to re-certify and re-validate the clean room for production. During that time, continuing normal operating expenses were incurred at a rate of $\$ 375,000 per month.

Resolution

The claim was valued at €2,325,000

Description of event

A pharmaceutical company used a subcontractor to manufacture its capsules. A custom soft-gel encapsulation machine suffered a mechanical breakdown that required extensive repairs. The repairs and FDA revalidation took 6 months. Their existing inventory lasted only 2 months, resulting in 4 months of lost income.

Resolution

The claim was valued at €375,000

Description of event

Contaminated raw material was incorporated into a pharmaceutical company's product. The damage was not discovered until a number of batches were produced, affecting a large volume of finished product. Although only 10% of finished stock was directly contaminated, the FDA condemned all product batches.

Resolution

The claim exceeded **€225,000**

Description of event

A pharmaceutical employee was working with chemicals under a fume hood when a fire started as a result of a pressure gauge that was closed. The employee sustained facial, hand and arm burns.

Resolution

The claim was resolved for about €85,000
