

Chubb Hub AO24 Tennis Competition

Competition Terms and Conditions

Competition period: Thursday, 17 August 2023 – Friday, 17 November 2023

Promoter: Chubb Insurance Australia Limited, ABN: 23 001 642 020; AFSL: 239687 of Level 38, Grosvenor Place 225 George Street Sydney 2000.

Who is eligible to enter: Individual Authorised Representatives (ARs) or Brokers of one of the eligible Authorised Representative (AR) networks (Community Broker Network, Ausure Pty Ltd, United Insurance Group, Oracle Group, Resilium Insurance Broking).

How to participate: Eligible Individual ARs or Brokers can participate by utilising Chubb's market facing platforms (Sunrise and SCTP) to quote the following eligible products over the Competition period:

The individual AR or Broker must include their name and contact in the relevant sections when submitting quotes.

- a. Quotes and binds a minimum of \$10,000 AUD in new business base premiums on eligible products via Chubb's market facing platforms (Sunrise and SCTP) over the competition period.
