You are not investing in the Underlying Funds directly. Your investment under the Plan is subject to the charges of the Plan and the requirements set out in the Product Brochure of the Plan. Important Information that may be relevant to your investment

1. This Plan is not a bank savings product. All premiums you pay towards your Policy, and any investment made by the Company in the Underlying Funds of the Investment Options you selected, will become and remain the assets of the Company. You do not have any rights or ownership over any of those assets. Your recourse is against the Company only.
2. The premium(s) received from you will be invested by the Company into the Underlying Funds corresponding to the Investment Options as selected by you for our asset liability management. Units of each Investment Options allocated to your Policy are notional and solely for the purpose of determining the Account Value of your Policy.
3. This ILAS policy is subject to a surrender charge of up to 5% of the Account Value for within the first 5 Policy Years. It is only suitable for investors who are prepared to hold the investment for a long term period.
4. If you are not prepared to hold your policy for at least 5 Policy Years, this ILAS policy is not suitable for you and it may be cheaper to purchase an insurance policy and make separate fund investments. You should seek independent professional advice.
