1. What is Marine Services Liability Insurance?

This policy provides liability insurance for organisations involved in ship repair and marina operations. It covers legal liabilities arising from personal injury, property damage (including watercraft and cargo), removal of wreck, and consequential loss, resulting from business operations during the policy period and within the policy territory.

2. Know Your Coverage

3. Know Your Obligations

4. Other Key Terms

- Your duty of disclosure
Before entering into an insurance contract, you have a duty to disclose to us any matter that you know to be relevant to our decision on whether to accept the risk or not and the rates and terms to be applied; or a reasonable person in the circumstances could be expected to know to be relevant.
You have this duty until we agree to insure you.
You have the same duty before you renew, extend, vary or reinstate an insurance contract.
- This Policy together with its Schedule and any attached Endorsements is a legal contract which shall constitute the entire contract between the parties.
- Please ensure that there is an appropriate Limit of Liability taken up.
- There is a Deductible amount which you have to bear before we pay a claim.
- The policy is subjected to 60 days Premium Payment Warranty, i.e. premium due must be paid and received by Chubb (or the intermediary through whom this Policy was effected) within sixty (60) days from inception. Failing which, the policy is automatically cancelled and sixty (60) days pro-rated time on risk premium shall be payable to Chubb.
- In the event of any occurrence that likely to give rise to a claim, you have to give written notice to us of such claim as soon as possible after it comes to your knowledge.

Yes. You may cancel your policy at any time by giving a written notice to us. If there are no matters notified to us under this Policy, we will allow a refund of unearned premium calculated in accordance with our customary short-term rates.
