Risk Engineering Exchange

The Exchange provides direct communication between you and Chubb. The application is organized into three sections: the dashboard, recommendations, and documentation.

The **Dashboard** summarizes recommendations and provides quick links to easily navigate to supporting functions. From this home screen, you'll be able to:

- View top 5 **recommendations**.
- Identify trends among your locations to spot potential trouble areas.
- Report a fire protection system impairment.
- Request a boiler inspection.
- Ask a technical question with a direct line to a Chubb risk engineering expert.

The **Recommendations** section displays all open and closed recommendations. To hone in on key issues, you can easily filter or search recommendations by location, category, coverage, or keyword. You can respond to open recommendations, including the ability to upload attachments and supporting documentation.
